## PATIENT STATUS



**Impairments – 51% of adults have problems in body function or structure, such as significant deviation or loss**

**16% of pediatrics have problems in body function or structure, such as significant deviation or loss**

**Behavior – 18% of adults need enhanced staffing for behavioral reasons**

**61% of pediatrics need enhanced staffing for behavioral reasons**

## LIFESTYLES



**Activity Limitations – 64% of adults have difficulties in executing activities, based on nature, duration, and quality**

**67% of pediatrics have difficulties in executing activities, based on nature, duration, and quality**

**Intended Discharge Environments – 38% of all adult clients were discharged to their homes**

**54% of all pediatric clients were discharged to their homes**

## HEALTH



**Medical Acuity – Living level of 1 at the Lighthouse is 32% of all adult residents**

**Living level of 1 at the Lighthouse is 16% of all pediatric residents**

**Medical Stability – Living level of 2 or better is 68% of all adult residents**

**Living level of 2 or better is 84% of all pediatric residents**

## MENTAL HEALTH



**Participant Restrictions – 12% of adults have participation restrictions for involvement in life situations**

**66% of pediatrics have participation restrictions for involvement in life situations**

**Psychological Status – 22% of adults are not behaviorally stable, 78% of adults are behaviorally stable**

**50% of pediatrics are not behaviorally stable, 50% of pediatrics are behaviorally stable**
